In the summer of 2008, construction was begun on a new children's center providing an enlarged and permanent home for the Aschiana charity in Kabul. Aschiana Foundation provided the majority of the funds for this building. Progress was verified by an independent contractor who examined the state of the construction and documented it with photos. Construction was completed in May, 2011.

Aschiana Foundation supports the primary programs of providing educational and vocational skills to the working street children in Afghanistan. For much of the period this program impacted more than 3,500 children that would otherwise not have had access to education. Aschiana also provides the children with at least one nutritious meal a day and education pertaining to health and safety.
