**Other Changes in Net Assets Balance (990 EZ, Line 220):** Since the sudden death of one of the founders in 2006, Square Peg's financial and accounting systems have been managed by volunteers. Through the years, three new accounting systems have been utilized. In an effort to be financially transparent, management attempted to internally audit the accounts of the organization. Errors were found. Mgmt has attempted to "clean up" the books and records in F'2010 - including only verifiable assets and liabilities. This caused the adjustment.

**Schedule 3: Total Program Services Expenses:** \$ 113,369

**Horse Related Expenses:** \$ 26,564, Camp Related: \$ 1,152, Auto Related: \$ 6,107, Facilities: \$ 55,526, Payroll: \$ 24,020

**Lines 28, 29, and 30:** One of Square Peg's missions is the rescue of horses. Many of the horses rescued by Square Peg have been injured or suffer medical issues. At considerable expense, Square Pegs feeds, houses and cares for the horses (Line 28). Some (4 this FY) of the horses can be re-homed in an suitable environment. Others (that have suitable disposition) are retrained to assist in an adaptive riding program for emotionally, physically and learning disabled children (Line 30). Some adopted horses can be neither retrained nor re-homed". Sanctuary is given to these horses (Line 29). Due to the triple-mission of this organization, all centered around the high cost of feeding, housing and caring for the horses, it is not possible to accurately break out the expenses by mission.

**Loan Payable to Officers:** At the end of F'09, Square Peg owed its founder \$ 5169. Beginning in '05, Joell and Darius lent funds to Square Peg to fund the operations of the organization. This remaining balance, along with interest earned through the period, was fully repaid in F'10.
