THE NOTAH BEGAY III FOUNDATION'S ACTIVITIES ARE FOCUSED ON THE DEVELOPMENT OF MODEL AND EVIDENCE-BASED SPORTS, WELLNESS AND LEADERSHIP DEVELOPMENT PROGRAMS FOR NATIVE AMERICAN YOUTH, PRIMARILY IN THE FORMS OF SOCCER AND GOLF. THE FOUNDATION PROVIDED SOCCER PROGRAMMING AND TECHNICAL ASSISTANCE TO 1,884 NATIVE AMERICAN YOUTH AND 86 ADULTS TO REDUCE OBESITY, INCREASE HEALTH, AND DEVELOP LEADERSHIP. PROGRAMMING INCLUDED PROVIDING SPRING, SUMMER, AND FALL SOCCER LEAGUES, SUMMER PLAYER DEVELOPMENT CAMPS AND CLINICS TO PROVIDE EDUCATION, TRAINING, AND CERTIFICATION TO VOLUNTEER COACHES IN NEW MEXICO, SOUTH DAKOTA, AND CALIFORNIA. THE FOUNDATION ALSO INCREASED ACCESS TO SPORTS FOR NATIVE AMERICAN YOUTH THROUGH JUNIOR GOLF PROGRAMS SERVING 2,016 YOUTH. PROGRAMMING INCLUDED MODEL PROGRAM INITIATIVE IN THE TO'HAIILEE COMMUNITY OF THE NAVAJO NATION, SUMMER JUNIOR GOLF PROGRAMMING, AND GOLF EDUCATION AND OUTREACH TO SCHOOLS IN TRIBAL COMMUNITIES IN NEW MEXICO. SMALL GRANTS WERE PROVIDED TO 12 TRIBAL COMMUNITIES AND ORGANIZATIONS IN 6 STATES. THE FOUNDATION AWARDED \$60,000 IN SMALL GRANTS TO ASSIST IN THE DEVELOPMENT OF RECREATIONAL FACILITIES TO SUPPORT SPORTS AND PHYSICAL FITNESS ACTIVITIES AND SUPPORT FOR DIABETES PREVENTION, PHYSICAL FITNESS, AND LEADERSHIP DEVELOPMENT PROGRAMMING FOR NATIVE AMERICAN YOUTH.
