The school administrator withdraws funds and submits a monthly accounting report of expenditures to the President of Hope for Humanity, Inc. These reports are monitored for appropriate expenditures along with the monthly statements from the bank in Sudan. Periodic on-site visits and reviews are made by the President and Board members.
