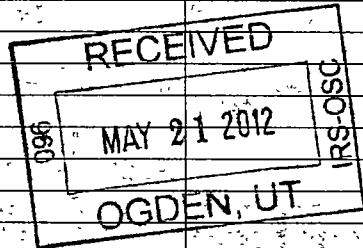

iBridge Network

The Organization is working to advance Innovation in the United States by focusing primarily on the iBridge Network (the "Network"). Through a web-based application and related services, the Network provides the research community an additional channel through which to disseminate discoveries, research methods, and findings and provides users access to research that may have otherwise been lost by increasing awareness of existing research across the country and facilitating exchanges among those who are conducting and/or using the research; the Network aims to expand the number and scope of collaborative relationships. Universities may use the iBridge Web site to license and distribute a variety of items including software, research tools, databases, teaching materials, surveys, and reference materials. Posting may include a variety of research material and descriptions of ongoing research activities. The Organization provides training with respect to utilizing the iBridge Web site and provides educational symposia on topics relating to fostering innovation and technology transfer. Currently there are over 17,000 research projects listed on the Network, and 159 institutions participating in the iBridge program. There were an estimated 470,000 visits to the website as of June 30, 2011.
