Our most significant efforts in the past year included taking the lead in opposing the nomination of Solicitor General Elena Kagan to the Supreme Court marshalling grass-roots, earned media, and social media, as well as briefings of senators and staffers and a video project making the case against her nomination. We advocated for the preservation of constitutional limits on government in the context of the landmark health care litigation in the Northern District of Florida and the Eleventh Court of Appeals. We filed a FOIA request as the first step to building a legally rigorous case for Justice Kagan's recusal in that litigation. We also promoted fidelity to the Constitution through commentary on judicial decisions and legislation, and encouraged state judicial selection systems that provide democratic accountability.
