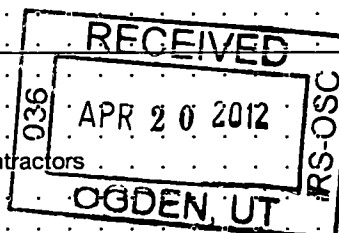

funds were released from restriction and recognized as revenues in the current year.
