THE CHELONIAN CONSERVATION CENTER, THE MAIN CONSERVATION PROJECT SPONSORED BY THE ORGANIZATION, BREEDS ENDANGERED SPECIES OF TURTLES AND TORTOISES. THE PURPOSE IS TO FORM GENETICALLY DIVERSE ASSURANCE COLONIES TO PREVENT THE EXTINCTION OF THE SPECIES IN OUR CARE. THE ULTIMATE GOAL IS TO REPATRIATE SOME OF THE ANIMALS BACK INTO THEIR WILD HABITATS AT SOME POINT, AND ALSO WORK IN CONJUNCTION WITH OTHER ORGANIZATIONS WITH SIMILAR GOALS TO ESTABLISH GENETICALLY DIVERSE ASSURANCE COLONIES OF TURTLES AND TORTOISES.

THE US FISH AND WILDLIFE SERVICE ALSO CONTRIBUTED FUNDS FOR THIS PROJECT, WHICH WAS REPORTED ON THE PRIOR YEAR RETURN. THE \$ 9,400 GRANT TO DURRELL CONSERVATION TRUST HAS BEEN DISCLOSED IN SCHEDULE I. THE GRANT TO THE DURRELL CONSERVATION TRUST WAS MADE, AS THEY HAVE BEEN MANAGING A SIMILAR PROJECT IN MADAGASCAR FOR THE PAST TWENTY YEARS.
