Legal Services: Asylum Access provided legal information, advice, and/or representation to 3,634 refugees in Ecuador, Thailand and Tanzania seeking to assert their rights to live safely, move freely, work, send children to school, access healthcare and financial institutions, and take other steps to rebuild their lives.

Policy Advocacy: Asylum Access advocated for improved implementation of refugees' human rights as enshrined in international law, by working with host and donor governments, civil society, UNHCR and other institutions to help them better understand and redress violations of refugees' human rights.

Community Legal Empowerment: Asylum Access trained refugees to understand and assert their fundamental human rights. Strategic Litigation - Expenses: \$17,628

Asylum Access engaged in litigation in national courts in Ecuador and in the Inter-American Commission on Human Rights to secure refugees' release from unlawful or unjustified detention, to demand that the state protect women refugees from sexual or gender-based violence and investigate incidents of sexual or gender-based violence against women refugees, and to vindicate other fundamental human rights of refugees.

Movement-Building - Expenses: \$26,724

Asylum Access built the global refugee rights movement by engaging lawyers and advocates from around the world in advocacy to support refugees' fundamental human rights, and by forging alliances with other human rights advocacy organizations and initiatives to ensure that refugees are included in broader human rights movements such as women's rights, children's rights, and the rights of migrants.

Part VI, Governance, Management and Disclosure

Key employees' disclosures are recorded in email correspondence to directors or in staff meeting minutes.

Compensation for the Executive Director is determined by the directors following deliberation in a board meeting; the deliberation and decision are recorded in board meeting minutes. Prior to the deliberations, directors conduct an inquiry into compensation of the chief executive in similar organizations, looking at characteristics such as the nature of the organization, the skills and credentials required of the chief executive, the location, number of offices and total budget of the organization, and the extent of the responsibilities borne by the chief executive.
