Additionally, the Endowment generally has written grant agreements with the grantees, keeps detailed records of receipts available upon request, and drafts informal reports of how funds are used.

Part III, Column D: In fulfilling the mission of the Endowment, sixty thousand dollars (\$60,000) was provided to Plum Village Foundation of Pak Chong, Thailand. These funds were used to provide food, education, shelter, clothing, basic shared amenities, and necessary travel to support the monastic life of the 160 monks and nuns residing at the monastery that train in the practice of Engaged Buddhism in the tradition of Thich Nhat Hanh.

The UBC Endowment has taken a number of precautions to ensure that this transaction remains fair and does not violate the excess

benefit transaction rules. First, and most important, all investors in funds held by the Hussman Trust and managed by Hussman

Strategic Advisors, including the UBC Endowment, pay the same fees. The fees paid to Hussman Strategic Advisors are determined

by the open market and on an arms' length basis. A considerable number of persons have chosen to pay these fees and confirm

the fairness of the price. As of June 30 2011, the two Hussman Funds that the UBC Endowment held investments in had over 200,000

shareholders and combined assets of approximately \$8 billion. Furthermore, the securities law require the independent trustees of the

Hussman Trust to review the fees and make a determination each year that the fees are reasonable. Finally, the legal counsel for the

UBC Endowment has drafted a formal legal opinion stating that the fees are reasonable.
