ADDITIONALLY, IINTIME COLLABORATES WITH NEW YORK UNIVERSITY TO DISTRIBUTE THE SURGICAL EDUCATION MODULES CREATED SIMILARLY TO IINTIME'S CASES (WEB INITIATIVE FOR SURGICAL EDUCATION OF MEDICAL DOCTORS - WISE-MD) ECLIPPS (EXTENDED CLIPP SCENARIOS) CONTINUE TO BE DEVELOPED WITH AN ANTICIPATED EVOLUTION TO A PROGRAM TO BE NAMED FOUNDATIONS FOUNDATIONS WILL CROSS THE MEDICAL DISCIPLINES OF MEDU PROVIDING FOR CONSISTENCY IN PEDAGOGY AND OFFERINGS IN CONTENT SUCH AS PROFESSIONALISM IN MEDICINE, CULTURE IN HEALTH, AND THE LIKE. MEDU VIRTUAL PATIENT CASES ARE OFFERED BY SUBSCRIPTION THROUGH IINTIME. TO FURTHER IINTIME'S MISSION AND TO ENSURE THE TEACHING CONTENT OF THE VIRTUAL PATIENT CASES REMAINS CURRENT AND ALIGNED WITH NATIONALLY ACCEPTED CURRICULA, EACH CASE SET HAS AN EDITORIAL BOARD CONSISTING OF EDITORS-IN-CHIEF, ASSOCIATE EDITORS, AND CASE EDITORS, ALL OF WHOM ARE TASKED WITH MAINTAINING THE QUALITY OF THE CASE CONTENT. ADDITIONALLY, THE EDITORS-IN-CHIEF OF EACH CASE SET JOIN TOGETHER TO FORM THE MEDU EDITORIAL BOARD. THE MEDU EDITORIAL BOARD WORKS TO ENSURING THE IINTIME OFFERINGS MEET THE NEEDS OF STUDENTS, TEACHING FACULTY, AND SUBSCRIBING INSTITUTIONS. IN ADDITION TO ITS VIRTUAL PATIENT CASES, IINTIME, OFFERS TEACHING TOOLS AND USER SUPPORT. THE PASSWORD-PROTECTED AREA OF ITS MEDU WEB SITE OFFERS INTEGRATION TOOLS, SUGGESTED WAYS IN WHICH THE CASES CAN BE USED TO MEET ACCREDITATION REQUIREMENTS, CASE SUMMARIES, A CASE LIST, A CASE SEARCH TOOL, ACCESS TO THE CASES AND ACCESS TO STUDENT CASE USE LOG DATA. IINTIME STAFF AND COLLABORATORS ALSO SUPPORT IINTIME SUBSCRIBERS THROUGH WORKSHOP OFFERINGS AT NATIONAL MEETINGS, AVAILABILITY AT NATIONAL EXHIBITS, AND THROUGH INDIVIDUALIZED TUTORIALS ASSOCIATED WITH THE CASE SETS ARE ASSESSMENT TOOLS. CLIPP OFFERS A VALIDATED EXAM, INCLUDING A SCORING SERVICE, TO ITS SUBSCRIBERS.
