Pride Academy Charter School commenced implementation in the 2008-2009 school year and has just completed its third year of operation. The school's charter authorized a maximum enrollment of 240 students in Grades 5-8. The enrollment at the beginning of the school year was 240 students. At the end of the year the enrollment was 239 students, with one open 8th grade spots. There are three classes each of Grades 5, 6, 7, and 8. During the 2010-2011 school year, the Charter School's Administrative team continued to lead the growth and strengthening of the school in the third year of operation. One of the highlights in accomplishments was to develop and implement a School Improvement Action Plan that addressed action plan steps that improved the quality of instruction, school operations, retention and expansion of quality staff.
