



After School Program: Using its own facilities and by partnering with Trenton Public Schools, the Boys & Girls Club expands learning time by more than 40 percent each school day, keeping kids safe, improving student achievement, and supporting families using a specific, evidenced-based, after-school program model.

4b (Code ) (Expenses \$ 87,758. including grants of \$ 0.) (Revenue \$ 0.)

Career Launch utilizes three nationally-tested programs. Career Explorers, Club Tech, and Job Ready prepare young adults for their future. Through these programs, career development specialists help Boys & Girls Club members to explore career and educational options. The three-pronged effort is designed to prepare youth members to join today's ever-changing workforce. Job Ready graduates are provided with paid internships, job shadowing opportunities, and help with job placement. College-bound students are offered assistance with applications, financial aid requests, and college visits.

4c (Code: ) (Expenses \$ 437,972. including grants of \$ 0.) (Revenue \$ 213,973.)

Summer Camp: School may be out in the summer but, at the Boys & Girls Club of Trenton, Adventure, Sports, and Teen Camps keep participants active and learning. Adventure Camp is for kids age five to 11. Sports Camp offers children age six through 12 the opportunity to participate in a variety of sports. Teen Travel Camp combines a weeklong schedule of trips, community service projects, team building, sports, and SMART Moves. Among the excursions are trips to Baltimore, Great Adventure, the Jersey Shore, local college campuses, and museums. The camp is designed for youth age 12 to 15 years and weekly sessions run from June to August.
