Anchor House shelter provides emergency housing, nutritious food, clothing, transportation, recreation and individual, family and group counseling to youth. The average stay is 16 days. The shelter provides for the immediate needs of runaway and homeless youth, while seeking to reunite youth with their families, strengthens family relationships, and help youth decide on a constructive course of action. Services are available 365 days a year, 24 hours a day. Hotline and drop in crisis intervention are available, as well as aftercare services once the youth leaves the shelter. Shelter residents can also take advantage of group services offered at other Anchor House programs. In addition, Anchor House works within the community to advocate for youth, and provides services to local schools

4b (Code:) (Expenses \$ 442,794. including grants of \$) (Revenue \$)

Angel's Wings provides emergency respite care for abused and neglected children from birth to age 12. Children receive shelter, food, clothing, medical attention, and individual therapeutic counseling. The Family Support Program serves not only the children who have resided at the home, but also their family members, as well as families in the community. Over 246 unduplicated children and their caregivers received ongoing services, with 685 duplicated individuals receiving some type of support.

4c (Code:) (Expenses \$ 484,170. including grants of \$) (Revenue \$ 572.)

The Anchorage offers long term transitional housing for homeless youth ages 18 to 21 lacking family support. Services include shelter, food, clothing, medical attention, psychological evaluations, individual and group counseling, life skills training, employment and educational services, as well as community referrals.

In 2011, there were a total of 22 youth staying at the Anchorage. For those that stayed past the probation period, a record 100% of youth pursued their high school diploma, GED, or post-secondary education. Despite the recession, 75% are employed. Long term results can be seen with our youth that graduate to our Anchor Line program. Youth are more successful when they continue with services including counseling

This year the program was restructured leading to an increase of the seven residents actively accessing supportive services, staying in college or certificate training programs, retaining employment and increasing their length of stay in the program.

Anchor Link, the Street Outreach Program, works directly with youth to help homeless and high risk youth leave their life on the streets. These youth are in danger of becoming victims of sexual exploitation and victimization and receive many services including crisis intervention, access to bathing facilities, kitchen and computers, survival aids, individual and group counseling, workshops on violence prevention and sisterhood, links to emergency housing and transitional living arrangements, as well as referrals and information regarding other available services.
