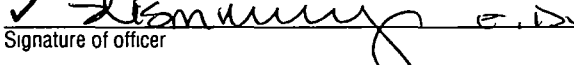

SHELTER SERVICES - COLUMBUS HOUSE PROVIDES EMERGENCY SHELTER IN A YEAR-ROUND FACILITY WHICH HAS THE CAPACITY OF 81 SINGLE ADULT MEN AND WOMEN WHO ARE HOMELESS. SHELTER SERVICES INCLUDE 2 MEALS, BREAKFAST AND DINNER, BASIC NEEDS SUCH AS SHELTER AND CLOTHING, AND CASE MANAGEMENT SERVICES FOR THOSE WHO NEED ASSISTANCE WITH HOUSING, MEDICAL CARE, MENTAL HEALTH AND /OR SUBSTANCE ABUSE TREATMENT, EMPLOYMENT SUPPORT AND OTHER SERVICES. PARTICULAR PROGRAMS WITHIN THE SHELTER ARE PROVIDED FOR SUB-POPULATIONS, SUCH AS THOSE WITH MORE PROLONGED MENTAL ILLNESS, FOR VETERANS, FOR PEOPLE COMING OUT OF PRISON. THE OVERFLOW SHELTER IS A WINTER ONLY FACILITY, WITH CAPACITY FOR 75 MEN. WHILE BASIC NEEDS ARE PROVIDED, CASE MANAGEMENT SERVICES ARE LIMITED IN THIS FACILITY.

SUPPORTIVE HOUSING SERVICES - SUPPORTIVE HOUSING ENCOMPASSES BOTH TRANSITIONAL AND PERMANENT SUPPORTIVE HOUSING FOR SINGLE ADULT MEN AND WOMEN. TRANSITIONAL HOUSING'S PRIMARY GOAL IS TO FACILITATE THE SUCCESSFUL TRANSITIONAL OF HOMELESS ADULTS INTO STABLE AND AFFORDABLE PERMANENT HOUSING WHILE PROVIDING THEM WITH THE SKILLS NEEDED TO KEEP THEM HOUSED AND INDEPENDENT. THE FOCUS OF THE TWO TRANSITIONAL PROGRAMS IS ON RECOVERY, MENTAL HEALTH AND SUBSTANCE ABUSE TREATMENT, EMPLOYMENT, LIFE-SKILLS TRAINING AND HOUSING. COLUMBUS HOUSE PROVIDES 36 UNITS OF TRANSITIONAL HOUSING, ONE FOR WOMEN (SOJOURNER'S PLACE) AND ONE CO-ED (ON THE MOVE).

THE PRIMARY GOAL OF PERMANENT SUPPORTIVE HOUSING IS TO PROVIDE SAFE,

BUILDING BRIDGES (BBR) IS A PROGRAM THAT ENGAGES MEN WHILE THEY ARE IN PRISON AND ASSISTS WITH THEIR TRANSITION BACK INTO THEIR COMMUNITY. THE SERVICES OFFERED INCLUDE CASE MANAGEMENT AND EMPLOYMENT SUPPORTS.
