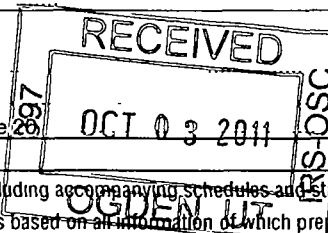

TUTORING PROGRAM - MERCY LEARNING CENTER'S PART-TIME TUTORING PROGRAM SERVES THE MAJORITY OF THE ADULT LEARNERS ENROLLED AT THE CENTER. THE FLEXIBILITY OF PART-TIME ATTENDANCE ALLOWS WORKING WOMEN AND THOSE WITH OTHER RESPONSIBILITIES OR LIMITATIONS THE ABILITY TO PURSUE THEIR GOALS OF COMPLETING THEIR EDUCATION. ALL OF THE ADULT EDUCATION PROGRAMS AT MERCY LEARNING CENTER ARE AIMED AT INCREASING WOMEN'S EDUCATIONAL FUNCTIONING LEVELS SO THAT THEY MAY BECOME MORE PRODUCTIVE MEMBERS OF THE WORKFORCE AND THE COMMUNITY. STUDENTS WHO ENTER THIS PROGRAM RANGE FROM THE NON-READER TO THOSE PREPARING FOR THE GED EXAM.

IN 2010-11, 422 WOMEN WHO HAILED FROM 40 COUNTRIES PARTICIPATED IN THIS PROGRAM, 98% OF WHOM WERE LIVING AT OR BELOW THE FEDERAL POVERTY GUIDELINES. THESE STUDENTS RECEIVED INSTRUCTION IN A ONE-ON-ONE OR

EDUCATIONAL CHILDCARE PROGRAM - FREE EDUCATIONAL CHILDCARE AT MERCY LEARNING CENTER ELIMINATES BARRIERS TO LEARNING AND PROVIDES AN EDUCATIONAL OPPORTUNITY FOR CHILDREN WHO WOULD NOT OTHERWISE BENEFIT FROM A FORMAL PRESCHOOL EXPERIENCE. WHILE THE MOTHERS STRIVE TO REACH THEIR EDUCATIONAL GOALS IN MERCY LEARNING CENTER'S ADULT EDUCATION PROGRAMS, THEIR CHILDREN ARE LOVINGLY CARED FOR IN THE CENTER'S ON-SITE INFANT AND TODDLER ROOMS AND ARE INTRODUCED TO EARLY CHILDHOOD LEARNING.
