THE STAFF OF HOUSING DEVELOPMENT AND FINANCIAL PROFESSIONALS SPECIALIZES IN THE CREATION OF AFFORDABLE HOUSING UNITS FOR THOSE MOST IN NEED OF SAFE AND DECENT HOMES. 
