In 2010-2011, Legal and First Response Advocates assisted 1,607 clients. Lawyers in AWP's Legal Assistance program handled 218 cases. AWP attorneys secured \$ 306,313.00 in support and \$ 123,000.00 in divorce assets for clients who, otherwise, would not have had any representation.4b (Code:) (Expenses \$ 710,053. including grants of \$ 36,463.) (Revenue \$)Counseling: The Counseling Project at A Woman's Place (AWP) combines individual and group counseling, a nationally recognized Medical Advocacy Project, 24-hour hotline services, as well as shelter based empowerment counseling. On average, AWP answers 350 calls a month on the Hotline. In 2010-2011, AWP provided shelter for 71 adults and 79 children. Counselors provided 13,686 hours of counseling to individuals and facilitated 1,055 hours of support group counseling.4c (Code:) (Expenses \$ 349,986. including grants of \$) (Revenue \$ 5,118.)Education & Training: Through education & training programs, AWP is committed to building the community's capacity to respond to and prevent domestic abuse and violence. Programs presented at elementary, middle, and high schools throughout Bucks County address awareness and prevention in an effort to stop abuse and violence before it starts. During 2010-2011, 195 school-based education programs were offered and reached 5,496 students. 315 prevention education programs were offered to 9,973 community members. Training healthcare professionals is another vital component of AWP's Education & Training Project, training 3,416 Bucks County professionals, during 201 medical programs, to better treat patients who may be victims of domestic abuse and violence.
