JHS used market data representing functionally comparable jobs within similarly situated organizations in making these compensation determinations. After the review and deliberation of the executive committee of the JHS Board, which was the responsibility of the compensation committee, compensation recommendations were reviewed and approved by the full JHS Board. The MLH CEO reports to the JHS CEO and is appointed by the JHS Board. The MLH CEO also reports to the MLH Board. Further, the Human Resources and Compensation Committee of the Main Line Health Board, using the services of an independent executive compensation consulting firm is responsible for evaluation and determining the total senior executive benefits and compensation for the EVP & Chief Financial Officer, hospital presidents, and other senior executives using both national and regional healthcare delivery market comparable compensation data. After review and deliberation, the committee documents its compensation decisions and reports to the full MLH Board of Governors who review and approve these compensation decisions.
