NOTES TO CONSOLIDATED FINANCIAL STATEMENTS

June 30, 2011 and 2010

NOTE A - BACKGROUND AND ORGANIZATION

The Gesu School, Inc. (the Organization), a Pennsylvania non-profit corporation, was founded in June 1993. The Gesu School, Inc. operates and administrates The Gesu School (the School), a private, full-time, nineteen classroom elementary school to educate children ages kindergarten through eighth grade. The School follows the curriculum used by Catholic elementary schools in the Archdiocese of Philadelphia, Pennsylvania. The Organization also conducts an after-school care program for children enrolled in the School and sponsors activities for children in the community including a youth choir, a discussion organization for adolescents, and a youth club that offers teenagers the opportunity to participate in a variety of activities, including sports, drama and leadership development.

These accompanying consolidated financial statements also include the accounts of the Gesu Institute, a Pennsylvania non-profit institute, which was founded in June 2005 for the purpose of strengthening and supporting schools that serve low-income communities, particularly in elementary education, as a means of bridging the gaps of inequality in our society. The Gesu Institute provides the necessary resources to evaluate, refine and develop best practices in teaching, governance, administration, and fundraising by using faith-based, value-based, and entrepreneurial models.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The Organization distinguishes between contributions received that increase permanently restricted net assets, temporarily restricted net assets and unrestricted net assets. The Organization reports amounts of total assets, liabilities and net assets in a statement of financial position, the change in an organization's net assets in a statement of activities, and reports the change in cash and cash equivalents in a statement of cash flows. The Organization's net assets and its revenues, expenses, gains and losses are classified based on the existence or absence of donor-imposed restrictions.

Unrestricted net assets are not restricted by donors, or the donor-imposed restrictions have expired. Temporarily restricted net assets are primarily restricted for capital expenditures and educational programs.

Permanently restricted net assets contain donor-imposed restrictions requiring that the principal be invested in perpetuity and investment income be used to support the Organization's activities.

2. Principles of Consolidation

The accompanying consolidated financial statements include all accounts and operations of The Gesu School, Inc. and its affiliate, the Gesu Institute, because The Gesu School, Inc. has both control of and an economic interest in the Gesu Institute. Intercompany accounts and transactions have been eliminated in consolidation.

3. Cash and Cash Equivalents

For purposes of the statements of cash flows, cash and cash equivalents include unrestricted cash in checking and money market accounts held by banks and custodial investment firms.

4. Investments

Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position. Other investments in partnership interests and private funds without readily determinable fair values are reported at fair value based on net asset value (NAV) in the statement of financial position. Donated marketable securities are recorded by the Organization at their fair values on the date of donation. Unrealized gains and losses are included in the change in net assets.

5. Tuition Receivable

Tuition receivable consists of amounts due from enrolled and former students. The Organization's management reviews the collectibility of these receivables at year-end and determines an appropriate allowance for doubtful accounts. Those balances that are still outstanding after management has used reasonable collection efforts are written off through a charge to the allowance for doubtful accounts and a credit to tuition receivable.

6. Property and Equipment

Substantially all of the Organization's property and equipment have been contributed to it and have been recorded at the related fair market value at the date of contribution. Purchased property and equipment are stated at cost. It is the Organization's policy to capitalize expenditures for these items in excess of \$1,000 and expense lesser amounts. Depreciation is provided over the estimated useful lives of the applicable asset using the straight-line method. Leasehold improvements are amortized over the respective lease term.

7. Deferred Revenues

Deferred revenues represent tuition and registration fees collected from students that pertain to the next fiscal year.

8. Public Support

Unconditional promises to give are recorded as received. Unconditional promises to give due in the next year are recorded at their net realizable value. Unconditional promises to give due in the second subsequent year and thereafter are recorded at the present value of their net realizable value, using an appropriate discount rate applicable to the years in which the promises are expected to be received to discount the amounts.

The Organization reports gifts of cash and other assets as restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. However, donor-restricted contributions whose restrictions are met in the same reporting period are reported as unrestricted support.

Contributions and investments are reported as unrestricted net assets unless they are either temporarily or permanently restricted as specified by the donor. Investment earnings available for distribution are recorded in unrestricted net assets. Investment earnings with donor restrictions are recorded in temporarily or permanently restricted net assets based on the nature of the restrictions.

The Organization receives use of its school facilities from St. Joseph's Preparatory School under a lease agreement that expires on May 31, 2055. Under this agreement, the Organization is not required to pay any rent; however, it is required to pay for all repairs and maintenance of the facility and for utilities. The value of the contributed facilities for the years ended June 30, 2011 and 2010 was \$920,500 and is included in contribution revenue in the statements of activities based on the fair market value of the lease agreement with a corresponding charge to rent expense, which is included in school and related programs expense in the statements of activities.

9. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. Significant estimates include the allowance for doubtful accounts, discount on pledges receivable, useful lives of depreciable assets, fair value of alternative investments, and the fair value of the lease on the school building.

10. Tax Status

The Organization and its affiliate are qualified public charities under Section 501(c)(3) of the Internal Revenue Code and are exempt from federal and state income taxes. Therefore, no provision for income taxes has been made in the accompanying consolidated financial statements.

NOTE D - FAIR VALUE MEASUREMENTS

The Organization has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the hierarchy are described below:

Level 1 Financial assets and liabilities whose values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 Financial assets and liabilities whose values are based on one or more of the following:

1. Quoted prices for similar assets or liabilities in active markets;
2. Quoted prices for identical or similar assets or liabilities in non-active markets;
3. Pricing models whose inputs are observable for substantially the full term of the asset or liability; or
4. Pricing models whose inputs are derived principally from or corroborated by observable market data through correlation or other means for substantially the full term of the asset or liability.

Level 3 Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's own assumptions about the assumptions a market participant would use in pricing the asset or liability.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the level in the fair value hierarchy within which the fair value measurement in its entirety falls has been determined based on the lowest level input that is significant to the fair value measurement in its entirety. The Organization's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment, and considers factors specific to the asset or liability.

Both observable and unobservable inputs may be used to determine the fair value of positions that the Organization has classified within the Level 3 category. As a result, the unrealized gains and losses for assets and liabilities within the Level 3 category presented in the tables below may include changes in fair value that were attributable to both observable (e.g., changes in market interest rates) and unobservable (e.g., changes in unobservable long-dated volatilities) inputs.

A review of the fair value hierarchy classifications is conducted on an annual basis. Changes in the type of inputs may result in a reclassification for certain financial assets or liabilities. Reclassifications impacting Level 3 of the fair value hierarchy are reported as transfers in/out of the Level 3 category as of the beginning of the year in which reclassifications occur.

The following tables present information about the Organization's assets and liabilities measured at fair value on a recurring basis as of June 30, 2011 and 2010, and indicate the fair value hierarchy of the valuation techniques utilized by the Organization to determine such fair value.

The following provides a brief description of the types of financial instruments the Organization holds, the methodology for estimating fair value, and the level within the hierarchy of the estimate.

1. Cash and Cash Equivalents

Cash and cash equivalents are represented by commercial bank checking and saving accounts. In addition, mutual fund money market accounts are included in the total amount.

2. Investments

Equities: These equity investments values are based on quoted market prices in active markets and are evaluated as Level 1 inputs.

Stock and Bond Mutual Funds. These funds are primarily equity investments with readily available market prices. The Organization evaluates these items as Level 1 inputs.

Limited Partnerships: The limited partnerships are interests in private equity and REIT funds, representing the Organization's ownership interest in the NAV of the respective partnership. Investments held by the partnerships consist of marketable securities as well as securities that do not have readily determinable fair values. The fair values of the securities held by limited partnerships that do not have readily determinable fair values are determined by the general partner and are based on historical cost, appraisals, or other estimates that require varying degrees of judgment. If no public market exists for the investment securities, the fair value is determined by the general partner taking into consideration, among other things, the cost of the securities, prices of recent significant placements of securities of the same issuer, and subsequent developments concerning the companies to which the securities relate. These investments are evaluated as Level 3 inputs

NOTE F - UNRESTRICTED NET ASSETS

The Organization's Board of Trustees has approved that a portion of the unrestricted net assets be directed into a board-designated endowment. Investment earnings from the board-designated endowment are reinvested but are available for distribution at the discretion of the Board of Trustees. Investment earnings from the board-designated endowment are recorded as increases in unrestricted net assets. The board-designated endowment totaled \$11,697,001 and \$10,131,474 at June 30, 2011 and 2010, respectively, and is included in the unrestricted net assets balance as of June 30, 2011 and 2010.

NOTE H - PERMANENTLY RESTRICTED NET ASSETS

Net assets were permanently restricted at June 30, 2011 and 2010 as follows:

- a. The \$100,000 and \$100,000 Edwin L. Knetzger Teaching Prize endowment established by an Organization trustee. Investment earnings from the teaching prize endowment are available to provide an annual award to a Gesu School teacher and are recorded as an increase in unrestricted net assets if the teaching prize is provided before the end of the fiscal year or as an increase in temporarily restricted net assets if not.
- b. \$3,879,721 and \$2,134,781 scholarship endowment established by various contributors. Investment earnings from the scholarship endowment are available to provide scholarships to at-risk children attending the School and are recorded as an increase in unrestricted net assets if the scholarships are provided before the end of the fiscal year or as an increase in temporarily restricted net assets if not. In the event that income from the endowment exceeds the need for scholarships in a given school year, the income may be released to provide partial scholarships for other School students.

NOTE I - ENDOWMENTS

As required by accounting principles generally accepted in the United States of America, net assets associated with endowment funds, including funds designated by the Board of Trustees to function as endowments, are classified and reported based on the existence or absence of donor-imposed restrictions.

The Organization's endowment consists of a portfolio of actively managed funds established to provide both a source of operating funds as well as long-term financial stability. The endowment includes both donor-restricted endowment funds and funds designated by the Board of Trustees to function as quasi-endowments.

1. Interpretation of Relevant Law

The Organization adopted the Commonwealth of Pennsylvania Act 141 (Act 141) as of July 1, 2010. The Organization interprets Act 141 as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Organization classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. This is regarded as the "historic dollar value" of the endowed fund. The remaining portion of the donor-restricted endowment fund that is not classified in permanently restricted net assets and is regarded as "net appreciation" is classified as temporarily restricted net assets until those amounts are appropriated for expenditure by the Organization in a manner consistent with the Organization's spending policy.

2. Endowment Investment and Spending

The Organization has an investment committee that invests endowment assets to protect the future purchasing power of the principal of the endowed fund, providing a source of income to support the activities of the Organization.

The return objective is an average annual total real (inflation adjusted), rate of return of 5% to 7%, as measured over a three- to five-year market period.

The investment committee determines spending within the parameters of Act 141 (between 2% to 7% of endowment value). For the years ended June 30, 2011 and 2010, the investment committee determined spending to be 5%.

3. Strategies Employed for Achieving Objectives

The investment objectives for the endowment require disciplined and consistent management that accommodates all those events which are relevant, reasonable, and probable. The management of the endowment should ensure a total return (yield plus capital appreciation) sufficient to preserve and enhance, in real dollar terms, the principal funds endowed net of withdrawals to support the Organization.

The investments of the endowment shall be appropriately diversified so as to maximize expected returns while controlling risk. Investment managers will have complete investment discretion based on the expectation that the assets of the fund will be invested with care, skill, prudence and diligence.

NOTE L - RELATED PARTY TRANSACTIONS

A majority of the Gesu Scholarship Fund's (an affiliated organization) Board of Trustees are also employees and trustees of the Organization. The Organization received contributions of \$213,568 and \$204,881 for student scholarships and \$66,541 and \$76,679 in management fees for administrative and fundraising assistance from the Gesu Scholarship Fund during the years ended June 30, 2011 and 2010, respectively.

NOTE M - EMPLOYEE RETIREMENT PLAN

All full-time employees who have one year of service and have attained the age of 21 are eligible to participate in the defined contribution retirement plan. Pension expense for the years ended June 30, 2011 and 2010 was \$9,850 and \$7,290, respectively.

NOTE N - SUBSEQUENT EVENTS

The Organization evaluated its June 30, 2011 consolidated financial statements for subsequent events through February 3, 2012, the date the consolidated financial statements were available to be issued. The Organization is not aware of any subsequent event which would require recognition or disclosure in the consolidated financial statements.
