Mercy Hospital Foundation ("The Foundation") provided \$625,413 in funding in fiscal year 2011 to Mercy Hospital Iowa City for facility improvements, medical equipment, patient comfort items and educational materials and programs, nursing and health career scholarships, and support for specific areas including Mercy Hospice Care, Mental Health Services, Cardiology, Diabetes Education and Cancer Care Services. One of Mercy's newest services is Mercy Hospice Care which has provided end-of-life care to more than 500 patients since its opening in April, 2009 (See Schedule O). In addition to gifts that are designated for specific purposes in this area, many gifts are made to the Hospice Endowment Fund to ensure that care will continue to be available to anyone who needs it. The Mercy Foundation was able to complete a \$1 million pledge in 2011 to support the construction and services of Mercy Hospice Care. Mercy's scholarship program continues to grow. In addition to providing renewable \$1,000 Health Career Scholarships to graduating high school seniors in Mercy's 10-county service area who plan to major in a health care career in college, Mercy also awards Nursing Scholarships to employees who are continuing their advanced nursing education. In 2011 ten students received new Health Careers Scholarships, 21 received renewals and 52 Nursing Scholarships were awarded to 37 employees. The Foundation provides books and other educational materials as a part of the care to patients who have been diagnosed with diabetes. An endowment fund to support Mental Health Services has been started to support the comprehensive and holistic services that Mercy provides in its inpatient unit. The medical equipment serves a general population of this hospital. The patient comfort items, educational materials and programs are directed by hospital staff to the appropriate patients.
