THE FOUNDATION RECEIVED CONTRIBUTIONS FROM 2,085 DONORS IN THE FISCAL YEAR ENDING 6/30/2011 AND CONTRIBUTIONS FROM 2,869 DONORS IN THE FISCAL YEAR ENDING 6/30/2010. DONATIONS ARE RECEIVED FROM A WIDE VARIETY OF PERSONS INCLUDING ALUMNAE OF THE UNIVERSITY, BUSINESS AND NON-BUSINESS RESIDENTS OF THE NORTH GEORGIA COMMUNITY, AND PRESONS/BUSINESSES GENERALLY INTERESTED IN SUPPORTING THE SCHOOLS ACADEMIC PROGRAMS. THE BOARD OF TRUSTEES OF THE FOUNDATION CONSISTS OF UNIVERSITY ALUMNAE AND MEMBERS OF THE BUSINESS COMMUNITY IN THE STATE OF GEORGIA. THE BOARD OF TRUSTEES OF THE FOUNDATION CONSISTS OF UNIVERSITY ALUMNAE AND MEMBERS OF THE BUSINESS COMMUNITY IN THE STATE OF GEORGIA. BASED ON THE ABOVE FACTS AND CIRCUMSTANCES AND THE FACT THAT THE FOUNDATION'S CURRENT PUBLIC SUPPORT TEST IS 29.81%, THE FOUNDATION BELIEVES THAT ITS MEETS THE 10% FACTS AND CIRCUMSTANCE TEST AND THEREFORE, CONTINUES TO BE A PUBLIC CHARITY.
