all Trustees and staff members to annually complete a "Conflict of Interest" affidavit
disclosing any potential conflicts. Trustees and Staff are prohibited by the policy from
participating in any activity that creates or gives the appearance of a conflict between their
personal interest and the interests of the Organization.

Form 990 Part VI Section B Line 15a Review for the Executive Director is performed by the
Executive Committee. A Performance Appraisal if completed, then the Committee discusses
performance and salary increase.

Form 990 Part VI Section C Line 19 The Organization provides its governing documents, policies
and financial statements to members of the public upon request. The documents, policies and
financial statements are reviewed with Board members regularly.
