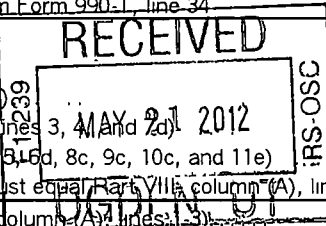

Support of TCC Academic Programs. A \$400,000 grant provided funding for TCC's Child
Development (Infant/Toddler) Program, which trains childcare workers on early
childhood development skills and effective teaching methods. The remaining \$30,000
was used to support TCC's participation in the Tulsa Alliance for Engineering. The
group consists of six Tulsa higher education institutions focused on exposing more
young people to engineering, thereby increasing the number of engineers in Tulsa and
northeastern Oklahoma.

4b (Code:) (Expenses \$ 377,949. including grants of \$) (Revenue \$)

Capital Projects and Equipment. These expenses include \$145,068 used to furnish and
equip TCC's Center for Creativity, completed in July of 2010. An additional \$232,881
was spent to purchase 12 dental chair operatories for the TCC Dental Hygiene Clinic,
in support of the indigent dental care clinic services and students' supervised
clinical learning environment.

Other Program Service Expenses for the year include \$135,451 for student scholarships
and \$27,669 to provide textbooks for students with financial need. An additional
\$71,816 was spent to support a variety of college activities and special campus
events. The Foundation expended \$54,436 to promote key relationships and support
critical initiatives in keeping with the college's strategic plan and values in the
communities we serve through sponsorships and program support. Finally, \$11,201 in
Foundation funds were used to recognize college employees selected for excellence in
job performance.
