28	Purandara Daasa Day(Religious event) towards the end of winter (Purandara Daasa is one of the pioneering exponents of Carnatic music - a classical art form that evokes the Lord's name through devotional music) The event is marked by members of our community taking turns to sing compositions of Purandara Daasa accompanied by instrumentalists This year, the event was expanded to include contributions of other Hindu saint composers (Daasas / Sharanas) whose devotional works have enlightened societies in Karnataka for many centuries Sharanas have composed "vachanas" that led to social/religious reform and religious awakening Thus, the event is now called "Daasa/Vachana Day" 2 Yugadi(Religious event) in spring (New Year celebration as per Hindu lunar calendar) - members come together to usher the New Year in a traditional way They wear new clothes, distribute sweets and wish each other There will be some presentation of traditional songs, dances and drama to show the way this religious holiday is celebrated in Karnataka Kids are introduced to the traditions and they enjoy knowing more about the religious aspect of the holiday 3 Ganeshotsava celebrations(Religious event) (an event dedicated to Hindu God Ganesha, remover of all obstacles) - this is a very important Hindu festival The program starts with the preparations to conduct the worship A Hindu priest leads the community in the worship, this includes chants in Sanskrit - an ancient language of India Members take part in the worship and pay respects to the Lord together The program continues with members singing hymns, devotional songs and traditional dance (Bharatanatyam) that are dedicated to Lord Ganesha 4 Deepavali celebrations(Religious event) - Deepavali is a Hindu festival of lights It signifies a person moving away from darkness (ignorance) towards knowledge - and it also signifies triumph of good over evil There are many religious meanings to this festival depending on the region of India - Lord Rama's return from jungle in the epic Ramayana, Pandavas' triumph over the evil Kauravas in a war (from the epic Mahabharata) ,and King Bali shown his destiny by Lord Vishnu as Vaamana (as in the legend Dashavataara) Talk show for education Koota invites various intellectuals and scholars for talk shows Their discussion focuses upon literary aspects, Indian culture, history and its relevance to contemporary times The idea is to teach the new generation Indian Americans their religion, the values and heritage and clarify their questions This will let them bridge their gap in understanding and also relating to their Indian roots Kids Competition and Talents show Children are the future of this nation Koota believes that encouraging and inspiring our kids helps us build better and smarter society The objective is also to make them learn and appreciate their religion Contests and Talent shows are the ways of attracting kids to participate and engage in our activities We also encourage youth to learn the art of photography Walk for hunger Koota works very hard organizing and mobilizing families to participate in the walk and generously donate money to "Project Bread's walk in Boston down town As immigrants in this society, Koota believes that it needs to give back to the community and fulfill the responsibility towards the society Feed the Hungry Koota organizes special drives to collect food from Koota families and donate to local food pantry Starting from July 2011, Feed the Hungry events are part of all Koota events This means multiple food drives are arranged over a year (Grants \$ 0) If this amount includes foreign grants, check here	28a	0
