such as IV Therapy, Wound Care, Palliative Care, and Psychiatric Care all from the comfort of the patient's home Approximately 2915 people were served by Alliance Visiting Nurses, with an average daily census of 305 A total of approximately 41,910 (including 381 non-billable) visits were completed by various disciplines VNA Alliance continues to provide a wealth of community services to the residents, organizations and various groups in Mercer, Crawford, and Venango Counties We have gained recognition as an agency that is a respected and one that is a contributing member of the community, truly making a difference in the lives of those residing in our geographical boundaries The focus of our community engagement is geared primarily towards educating and screening the retirement and low-income populations, as these groups seem to have the greatest need regarding health screening and health education We work closely with individuals who provide direct hands-on care or oversee the health care of these populations as well as general potential consumers of health care services in our communities Another identified need we have addressed is providing trainings/information to assist caregivers with providing health care to the geriatric and difficult-to-deal with individuals, such as those with dementia or Alzheimer's disease We also service the corporate community through health and wellness initiatives including speaking engagements and flu clinics for agency employees VNA Alliance Community Nurse Liaisons have provided the following services Free Blood Pressure Clinics BP readings are obtained and appropriate education is provided to assist clients with maintaining optimal levels of health and wellness Clients are instructed on the importance of these readings and the need to keep their BP in acceptable ranges Documentation of the level is recorded on a VNAA BP card and the client is encouraged to share this with the physician on their next visit Clients having blood pressures in very high or low ranges are often re-evaluated after several minutes of rest We work with the client to notify their PCP of unacceptable ranges and the importance of having their BP and health status re-evaluated and monitored to avoid potential health concerns VNAA participated in Blood Pressure assessment clinics including Telehealth monitoring services at the Crawford County Agency on Aging's Downtown Mall Senior Fest in May 2011 The Senior Fest served over 200 community residents In addition, blood pressure clinics are conducted monthly in Mercer County at St Paul's in Greenville and SV Ridgewood in Sharon, PA Several elevated Blood Pressures were detected Participants were educated regarding the concern and instructed to follow up with their physician As warranted, physician follow up forms were completed and sent to physicians in order to alert physicians regarding elevated blood pressures Speaking Opportunities VNAA works closely with many independent, assisted living and personal care home facilities as well as the local Area on Aging and many retirement organizations The Community Nurse Liaison along with staff at these facilities, identify areas of educational need for both the residents as well as staff This year, residents of these organizations and facilities have requested education in the areas of healthy eating, exercise programs and information regarding this year's flu vaccine and weather-related illnesses of heat stroke and hypothermia The underlying knowledge deficit that was prevalent among many staff in AL and PCH environments was the difficulty in effectively dealing and communicating with clients displaying signs of dementia and Alzheimer's disease They needed a basic education regarding dealing and communicating with clients displaying difficult behaviors Corporate Wellness and Education In our local communities, especially in small businesses, employers have great concern that employees remain healthy for 2 reasons one, concern for their employees well-being and two, concern that their employees would remain healthy and able to report to work to maintain the needs of their businesses We were able to provide much needed information as well as administration of flu vaccines through our VNAA flu clinics Other corporate wellness needs included exercise and healthy eating initiatives VNAA is often the speaker at staff meetings for various community social service organizations including AAA and Community Resources for Independence and for various Personal Care Homes and Assisted Living Facilities The Meadville Community Nurse Liaison is a Certified Diabetes Educator and offers ongoing training regarding diabetes education and medication management and insulin administration for the staff of Assisted and Independent Living Communities Organizations Served Wesbury Assisted living/independent living clients- Flu, BP clinics, speaking engagements, staff education St Paul's Assisted living/independent living clients- Flu, BP clinics, speaking engagements, staff education, newsletter articles Area Agency on Aging- Mercer, Crawford and Venango Counties Educational seminars, BP clinics, assist with Farmer's Market initiatives Independent & Assisted Living Facilities- many are low-income retirement communities BP & Flu Clinics Seminars,
