Additional mechanisms for civic engagement beyond ongoing community service or service-learning engagement- 90% of PACC campuses utilize both one-day service projects and service trips. 63% of PACC's campuses have incorporated civic engagement into their first-year experience service opportunities as well as capstone course.

Civic engagement in institutional strategic plans: The survey found that 94% of PACC's campuses identify service to the community in its strategic plans. More than two-thirds indicated that education for global citizenship, student leadership development and student civic engagement were emphasized in their institution's plans. Over 80% of PACC's campuses indicate that their presidents publicly promote civic engagement and provide fiscal support, while 75% of presidents participate in campus activities and serve on community boards.

Institutional infrastructure and support for civic engagement-In PA 45% of our campuses have a civic engagement office in Student Affairs, while 24% of those offices report within Academic Affairs.

Institutional supports for engaged faculty-Our data reflects that over 80% of PACC institutions provide both faculty development workshops and materials for reflection and assessment. Additionally, more than 2/3 provide grants for service-learning course design, support to attend conferences, and curriculum models and syllabi.

Martin Luther King Day-In January 2011, ten PACC member campuses organized community service events to celebrate the life of Dr. Martin Luther King, Jr. through mini-grants of \$ 350 provided by Pennsylvania Campus Compact. The MLK Day 2011 mini-grantees were; Alvernia University, Bucknell University, Gwynedd-Mercy College, Kutztown University, Lock Haven University, Messiah College, Millersville University, Washington & Jefferson College, Keystone College and Chatham University . As a result of the support provided by the mini-grants, these ten campuses recruited over 1,759 student and community volunteers to partner with 128 K-12 schools and community organizations for projects that ranged from winterizing homes to working with youth to painting public trash cans in revitalization efforts.

AmeriCorps Community Fellows-The purpose of the AmeriCorps Community Fellows program is to address compelling community needs in the areas of college access and success, while developing college students as active citizens. In exchange for committing to serving 300 hours over the course of the calendar year, Community Fellows receive an AmeriCorps Education award of \$ 1,175 or \$ 1,468 upon completion of their service. Through the 2010-2011 AmeriCorps Community Fellow Program, 249 college students served in minimum-time positions in
