THE ACLD TILLOTSON SCHOOL WAS FOUNDED IN 1972 AS A CO-EDUCATIONAL, NON-DENOMINATIONAL, PRIVATE SPECIAL EDUCATION DAY SCHOOL. THE SCHOOL PROVIDES INNOVATIVE SPECIAL EDUCATION PROGRAMS FOR STUDENTS FROM AGE 7 THROUGH 21 WHO DISPLAY MODERATE TO SEVERE SPECIFIC LEARNING DISABILITIES (SLD) AND RELATED DISORDERS. THE SCHOOL SERVES A SEVEN-COUNTY AREA - ALLEGHENY, ARMSTRONG, BEAVER, BUTLER, FAYETTE, WASHINGTON AND WESTMORELAND. THE ACLD TILLOTSON SCHOOL IS LICENSED BY THE PA DEPARTMENT OF EDUCATION AND APPROVED BY THE BUREAU OF SPECIAL EDUCATION (BSE) TO PROVIDE SPECIAL EDUCATION SERVICES TO STUDENTS WHO ARE UNABLE TO RECEIVE APPROPRIATE EDUCATION PROGRAMS IN THE PUBLIC SECTOR. CURRENTLY, ALL STUDENTS’ TUITION IS PAID FOR BY A FIXED SUBSIDY FROM THE PA DEPARTMENT OF EDUCATION AND THE REFERRING SCHOOL DISTRICT. DURING THE 2010-2011 ACADEMIC YEAR, THE SCHOOL SERVED A TOTAL OF 98 STUDENTS BETWEEN THE AGES OF 7 AND 20. ONCE AGAIN, ALL OF THE SENIOR CLASS SUCCESSFULLY COMPLETED THE PROGRAM. FOR OVER 26 YEARS, THE ACLD TILLOTSON SCHOOL HAS HAD OVER 96% OF ITS STUDENT BODY COMPLETE THE PROGRAM. THE COMPLETION RATE IS WELL ABOVE THE FEDERALLY REPORTED NORM OF 54% FOR STUDENTS WITH DISABILITIES.

HALF-DAY INSTRUCTIONAL SESSIONS ARE CONDUCTED DURING THE MONTH OF JULY. THE CENTERS ARE LICENSED BY THE PA DEPARTMENT OF EDUCATION. THE CENTERS PROVIDED SERVICES TO 16 STUDENTS DURING THE SUMMER OF 2010.
