- * providing CASA volunteers with financial support to purchase clothing, products for hygiene needs, school supplies, medical consultation costs, and other special needs requests and activities for abused and neglected CASA children through their respective CASA volunteers.

Without this support, many volunteer would not be able to or choose to become CASA volunteers or to pay for the above-listed needs of their court-appointed CASA dependent children. CASA volunteers serve as a voice or an advocate for these children in judicial proceedings in Cochise County.
