The WNC Regional Education Foundation was set up to assist with applying for grants for 18 public school systems and the Cherokee Central Schools in Western North Carolina. The major grant received by the Foundation was from Cherokee Preservation Foundation for \$220,000 with two objectives. Goal 1: To support and facilitate the meaningful engagement of students in the responsible and effective use of relevant technologies in their learning experiences. Four of the original area high schools, along with two new schools, actively participated in the regional network of Student Technology Advisory Councils (STAC) during fall semester 2010. This included 90 students participating in school-based activities. Three internet-based conferences were held for planning of school-based projects and regional events.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Goal 2: To provide Regional Professional Development Sessions. The grant provided a total of 36 WRESA facilitated regional professional development options/sessions for participating school systems. The sessions consisted of 15 online courses and 21 face-to-face courses; one course was a combination of online and face to face. The face-to-face courses were held at the WRESA and Cherokee Tribal schools locations with the bulk of the sessions being held at the Tribal schools during a July 11-14, 2011, Summer Institute. The registration for all sessions and the scheduling of all sessions was coordinated through the WRESA and by the WRESA staff. The Cherokee Tribal schools staff provided the facilities, technology coordination and services for the summer institute. The WRESA and Tribal schools staffs had numerous joint planning and coordination interactions before, during and after the Cherokee institute.

The simultaneous coordination of facility and technology needs for several national level trainers and regional participants in technology focused courses in the same facility was a very large and difficult task. Sufficient numbers of technological devices, appropriate space and sufficient and significant bandwidth had to be provided for numerous concurrent sessions. In some cases, additional training devices required by the national trainers had to be purchased for participant use. These items are stored at the WRESA and are used in providing additional technology training sessions. Sessions included: Moodle Bootcamp, Apple, Discovery Education, Moodle, Advanced, Common Core, & Google in the Classroom along with others.
