- a. In accordance with the Bylaws, each Member shall have the power to appoint three Directors of the Corporation under Article III, Section 2, and remove Directors of the Corporation under Article III, Section 13.
- b. In accordance with the Bylaws, the Members shall have the power to approve the appointment and removal of the person designated by the Board of Directors as the Corporation's Executive Director.
- c. The Members shall have the power to approve or refuse to approve any amendment to the Corporation's Article of Incorporation or the Bylaws, or any action required to be submitted to and approved by the voting members of a nonprofit corporation under the Nebraska Nonprofit Corporation Act.
