MDCCC addresses and alleviates poverty in the MD - DC area through a federally-funded AmeriCorps' VISTA grant. Through this grant, in FY2011 we provided full-time program coordinator positions to 22 of our member campuses and 88,600 service hours, at a value of \$1,917,688. We also provided over 100 students from over a dozen of our member campuses with scholarship awards from a Students in Service (SIS) grant in exchange for each giving 300 hours of service to their communities. Services contributed included, among others, tutoring at K-12 schools, building homes through Habitat for Humanity, and working at a medical clinic for low-income people. Through these and other initiatives, MDCCC continues to provide networking and professional development opportunities for our member institutions. In doing so, we are strengthening their ability to deepen and enhance their community partnerships and and service learning programs to build a culture of civically-engaged lifelong learners. Networking and professional development events include service learning and civic engagement conferences, service learning workshops, grant writing workshops, and an annual retreat for service learning and civic engagement practitioners.
