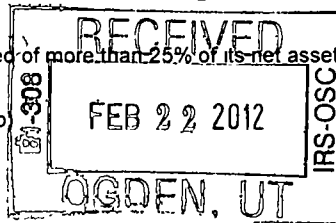

Additionally, the Fuller Center for Housing offers re-habilitation services to the elderly and poor who currently own homes that have fallen into disrepair. Those homes are typically brought up to local building code in order to allow the homeowner to live in a clean, safe environment. Once completed the homeowners are offered the opportunity to repay the organization, although such repayment is not required. Generally, the organization does not receive repayments on these projects.

Through its efforts, the Fuller Center for Housing provides on the job skill training through a cooperative effort with Youth Build America. The organization offers onsite technical training to participants in the Youth Build Program in the areas of electrical, plumbing and skilled carpentry to assist those participants in obtaining the skills necessary for them to eventually obtain gainful employment within the community.

The ReUse Center is a recycling center which offers opportunities for those who have either been incarcerated, or sentenced to community service to serve in various areas of the center. Those opportunities range from participating in home build projects or renovations to assisting in the operations of the center.
