INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying financial statements of the governmental activities and the major fund of Sunny Wolf Charter School (the School) as of and for the year ended June 30, 2011, which collectively comprise the School's basic financial statements as listed in the Table of Contents. These financial statements are the responsibility of the School's management. Our responsibility is to express opinions on these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America, and the standards applicable to financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the financial statement presentation. We believe our audit provides a reasonable basis for our opinions.

As described in Note 1, the School prepares its financial statements on the cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

In our opinion the financial statements referred to above present fairly, in all material respects, the respective financial position - cash basis of the governmental activities and the major fund of Sunny Wolf Charter School as of June 30, 2011, and the respective changes in financial position - cash basis thereof for the fiscal year then ended in conformity with the basis of accounting described in Note 1.

In accordance with Government Auditing Standards we have also issued a report dated November 18, 2011 on our consideration of the School's internal control over financial reporting and our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards and should be read in conjunction with this report in considering the results of our audit.

Accounting principles generally accepted in the United States of America require that the Management's Discussion and Analysis, the General Fund budgetary comparison information, and the Schedule of Funding Progress – Other Postemployment Benefits be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. However, the School has not presented the General Fund budgetary comparison. This budget comparison is not presented because the School is not required, under Oregon Local Budget Law, to adopt a budget. Also, the School has not presented a Schedule of Funding Progress – Other Postemployment Benefits schedule as required because the School has employees, but no actuarial study was completed for the valuation of post employment benefits. The School has not presented a Management's Discussion and Analysis in accordance with auditing standards generally accepted in the United States of America. However, our opinion on the basic financial statements is not affected by this missing information.

**Note 1 – Summary of Significant Accounting Policies**

**The Reporting Entity**

On January 20, 2010, the Sunny Wolf Charter School (the School), Wolf Creek, Oregon, was organized under provisions of Oregon Statutes pursuant to ORS Chapter 338 to operate within the Three Rivers School District for the purpose of operating an elementary school. The School is governed by a Board, appointed by the governing body of Three Rivers School District. All activities of the School have been included in the basic financial statements.

The School provides an elementary program for all students from kindergarten through grade five. The School is sponsored by the Three Rivers School District. The Charter School has a separate governing body, is a legally separate entity, but is not considered to be fiscally independent because it relies on the Three Rivers School District for its support through the ADMw process. Therefore, the School is included as a component unit of the Three Rivers School District's financial statements.

The financial statements of the Sunny Wolf Charter School have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. The Governmental Accounting Standards Board (GASB) is the accepted standard-setting body for establishing governmental accounting and financial reporting standards. In evaluating how to define the School for financial reporting purposes, management has considered all potential component units. Based on the application of the criteria established by the Governmental Accounting Standards Board (GASB), there are no potential component units of the School.

The more significant of the School's accounting policies are described below.

**Basis of Presentation**

**Government-wide Financial Statements**

The Statement of Net Assets and the Statement of Activities display information about the School. These statements include the governmental financial activities of the School. Governmental activities are financed primarily through payments of state school support passed through Three Rivers School District.

The Statement of Activities presents a comparison between direct expense and program revenues for each of its functions/programs. Direct expenses are those that are specifically associated with a function; therefore, are clearly identifiable to that function. Indirect expenses are those of the general government related to administration and support of the School's programs, such as personnel and accounting (but not depreciation) are allocated to programs based on their percentage of total primary government expenses. Program revenues may include: (1) charges to students or others fees, rentals, material, supplies are services provided, (2) operation grants and contributions and (3) capital grants and contributions. Revenues that are not classified as program revenues, including state support and federal grants, are presented as general revenues.

Net assets are reported as restricted when constraints placed on net asset use are either externally restricted, imposed by creditors (such as through grantors, contributors or laws) or through constitutional provisions or enabling resolutions.

**Fund Financial Statements**

The fund financial statements provide information about the School's funds. Separate statements for each fund category are presented. The emphasis of fund financial statements is on major governmental funds, each displayed in a separate column. The School has only one fund, and that fund is a governmental fund which is reported as a major fund:

General Fund – This fund currently accounts for all financial resources and expenditures of the School. The principal revenue sources are payments of state school support passed through Three Rivers School District.

**Measurement Focus and Basis of Accounting**

Government-wide financial statements are reported using the economic resources measurement focus, within the limitations of the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. The cash basis of accounting involves the measurement of cash and cash equivalents and changes in cash and cash equivalents resulting from cash receipt and disbursement transactions. Revenues are recorded when collected and expenses are recorded when paid. Non-exchange transactions, in which the School receives value without giving equal value in exchange, include grants, entitlements and donations. Revenue from grants, entitlements, and donations is recognized in the fiscal year received, regardless of when all eligibility requirements have been satisfied. Under terms of grant agreements, the School funds certain programs by a combination of specific cost-reimbursement grants and general revenues. Thus, when program expenses are incurred and there are both restricted and unrestricted net assets available to finance the program, it is the School's policy to first apply cost-reimbursement grant resources to such programs and then general revenues.

Governmental fund financial statements are reported using a "current financial resources" measurement focus, as applied to the cash basis of accounting. Only current financial assets are generally included on the balance sheet. Their operating statement presents sources and uses of available spendable financial resources during a given period. These funds use fund balance as their measure of available spendable financial resources at the end of the period. Expenditures are recorded when paid. Capital asset acquisitions are reported as expenditures in the governmental funds and proceeds from general long-term debt and acquisitions under capital leases are reported as other financing sources. With the cash basis of accounting, the use of cash to purchase a capital asset or to loan cash to another fund is reported as a cash disbursement and not as an asset.

If the School utilized the basis of accounting recognized as generally accepted, the fund financial statements for governmental funds would use the modified accrual basis of accounting. All government-wide financials would be presented on the accrual basis of accounting.

Private sector standards of accounting and reporting issued prior to December 1, 1989, generally are followed in the government-wide financial statements to the extent that these standards do not conflict or contradict the guidance of the Governmental Accounting Standards Board.

**Cash, Cash Equivalents and Investments**

The School's cash and cash equivalents consist of cash on hand and demand deposits.

**Capital Assets**

In the government-wide financial statements, capital assets arising from cash transactions are accounted for as capital outlay expenditures in the Statement of Activities. In the government-wide financial statements such costs would, under generally accepted accounting principles, be capitalized and depreciated over their useful lives.

In the fund financial statements, capital assets arising from cash transactions acquired for use in governmental fund operations are accounted for as capital outlay expenditures of the governmental fund upon acquisition.

**Retirement Plan**

Substantially all of the School's employees are participants in the State of Oregon Public Employees Retirement System (PERS). Contributions to PERS are made on a current basis as required by the plan and are charged as expenditures/expenses as funded. The 2003 Oregon Legislature passed PERS reform legislation and essentially created a new retirement plan for employees hired on or after August 29, 2003. These employees become members of the Oregon Public Service Retirement Plan (OPSRP). OPSRP is a hybrid retirement plan with two components: the Pension Program (defined benefit plan) and the Individual Account Program (defined contribution, established and maintained as a tax-qualified governmental defined contribution plan). OPSRP is administered by PERS.

**Grants and Other Operating Revenues**

Under the cash basis of accounting, the School receives funding from the Three Rivers School District through the State of Oregon based on the number of enrolled students. The School also receives grants passed through the Oregon Department of Education. These grants are on a reimbursement basis.

**Fund Equity**

In the government-wide financial statements, equity is classified as net assets and displayed in two components:

- a. Restricted net assets - Consists of net assets with constraints placed on the use either by (1) external groups such as creditors, grantors, contributors, or laws and regulations of other governments; or (2) law through constitutional provisions or enabling legislation.
- b. Unrestricted net assets - All other net assets that do not meet the definition of "restricted".

In the fund financial statements, governmental fund equity is classified in the following categories:

Non-Spendable -- Includes items not immediately converted to cash, such as prepaid items and inventory.

Restricted -- Includes items that are restricted by external creditors, grantors or contributors, or restricted by legal constitutional provisions.

Committed -- Includes items committed by the School's Board of Education, by formal board action.

Assigned -- Includes items assigned for specific uses, authorized by the School's Board of Education

Unassigned -- This is the residual classification used for those balances not assigned to another category.

**Budget**

A budget is prepared for the General Fund on the cash basis of accounting in the main program categories. This budgetary basis of accounting is in conformity with a comprehensive basis of accounting other than generally accepted accounting principles (GAAP) for the governmental fund types. As a Charter School, the Oregon Department of Education does not require the School to adopt a separate budget in accordance with Local Budget Law.

**Use of Estimates**

The preparation of basic financial statements, is in conformity with a comprehensive basis of accounting other than generally accepted accounting principles (GAAP) in the United States of America for the governmental fund types, requires management to make estimates and assumptions that effect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date the basic financial statements and reported amounts of revenues and expenses/expenditures during the reporting period. Actual results could differ from those estimates.

**Note 2 – Cash and Investments**

**Deposits.** The Governmental Accounting Standards Boards has adopted accounting principles generally accepted in the United States of America (GAAP), which include standards to categorize deposits to give an indication of the level of custodial credit risk assumed by the School at June 30, 2011. If bank deposits at year end are not entirely insured or collateralized with securities held by the School or by its agent in the School's name, the School must disclose the custodial credit risk that exists. Deposits with financial institutions are comprised of bank demand deposits. All deposits in excess of federal depository insurance are covered by the Public Funds Collateralization Program (PFCP) of the State of Oregon. The PFCP is a shared liability structure for participating bank depositories, better protecting public funds though still not guaranteeing that all funds are 100% protected. For the fiscal year ended June 30, 2011, the carrying amounts of the School deposits in various financial institutions were \$45,942, and the bank balances were \$52,898. All deposits are held in the name of the School. At June 30, 2011 the School's deposits were covered by federal depository insurance and Oregon's shared liability structure for participating bank depositories.

**Custodial Credit Risk.** Custodial credit risk for deposits is the risk that, in the event of a bank failure, a government's deposits may not be returned to it. The School does not have a formal deposit policy for custodial credit risk.

Effective July 1, 2008, House Bill 2901 created a shared liability structure for participating bank depositories in Oregon. Barring any exceptions, a qualifying bank depository is required to pledge collateral valued at least 10% of their quarter-end public fund deposits if they are well capitalized, 25% of the quarter-end public fund deposits if they are adequately capitalized, or 110% of the quarter-end public fund deposits if they are undercapitalized or assigned to pledge 110% by the Office of State Treasurer. In the event of a bank failure, the entire pool of collateral pledged by all qualified Oregon public bank depositories is available to repay the deposits of public funds of governmental entities.

**Note 4 – Pension Plan**

**Plan Description** - The School contributes to the Oregon Public Employees Retirement Fund (OPERF), a cost-sharing multiple-employer defined benefit pension plan administered by the Oregon Public Employees Retirement System (PERS).

PERS provides retirement and disability benefits, post-employment healthcare benefits, annual cost-of-living adjustments, and death benefits to plan members and beneficiaries. PERS is administered under Oregon Revised Statute Chapter 238. ORS 238.620 establishes the Public Employees Retirement Board as the governing body of PERS. PERS issues a publicly available financial report that includes financial statements and required supplementary information. That report may be obtained by writing to PERS, PO Box 23700, Tigard, Oregon 97281-3700 or by calling 1-503-598-7377.

**Funding Policy** - Members of PERS are required to contribute 6.00% of their covered salary under the plan. The School is required by ORS 238.225 to contribute at an actuarially determined rate. The current rate is 10.52% for employees hired before January 1, 2004 and 11.04% for employees hired after January 1, 2004 or salary covered under the plan for school districts. The contribution requirements for plan members are established by ORS Chapter 238 and may be amended by an act of the Oregon Legislature.

**Annual Pension Cost** - The School's contributions to PERS for the years ending June 30, 2011, 2010 and 2009 were \$11,180, \$0, and \$0 respectively, equal to the required contributions for each year. The School has an amount due to PERS of \$2,783 which represents employee deferrals.

**Note 5 – Contingencies**

Amounts received or receivable from grantor agencies are subject to compliance audits by grantors or their representatives. The amount, if any, of expenditures which may be disallowed by the granting agencies cannot be determined at this time although the School expects such amounts, if any, to be immaterial.

**Note 6 – Current Vulnerability Due to Certain Concentrations**

The School's operations are concentrated within Three Rivers School District boundaries. In addition, substantially all the School's revenues for continuing operations are from pass-through dollars from Three Rivers School District in the form of ADM.

**Note 7 – Risk Management**

The School is exposed to various risks of loss related to torts; theft of, damage to and destruction of assets; errors and omissions; and natural disasters for which the School carries commercial insurance. Worker's compensation insurance is also provided through a commercial carrier. This is the first year for the School.

**Note 8 – Implementation of GASB Statement No. 54 - New Fund Balance**

During the fiscal year, the School implemented GASB Statement No. 54. GASB Statement No. 54 requires analysis and presentation of fund balance in five categories. The new fund balance categories are:

Non-Spendable -- Includes items not immediately converted to cash, such as prepaid items and inventory.

Restricted -- Includes items that are restricted by external creditors, grantors or contributors, or restricted by legal constitutional provisions.

Committed -- Includes items committed by the School's Board of Education, by formal board action.

Assigned -- Includes items assigned for specific uses, authorized by the School's Board of Education.

Unassigned -- This is the residual classification used for those balances not assigned to another category.

**Note 9 – Subsequent Event**

Management of the School has evaluated events and transactions occurring after June 30, 2011 through the date of the financial statements were available for issuance, for recognition and/or disclosure in the financial statements. The School was informed in September 2011 by the Oregon Department of Education that the School will not be receiving the second and third year of the Charter School Implementation grant. The School was expecting approximately \$225,000 from this grant for two more years. The loss of this funding will cause the School to re-evaluate their financial plan. There were no additional events and/or transactions that required recognition and disclosure in the financial statements.

## **Accounting Systems and Internal Controls**

The School's accounting and internal controls systems are adequate. The internal controls for the School are operating as designed and no material weaknesses were noted.

## **Collateral**

Based on our review of the School's records, the School was in compliance with the provisions of ORS Chapter 295. The banks used by the School were considered qualified financial institutions for the year ended June 30, 2011.

## **Insurance and Fidelity Bond Coverage**

*We reviewed the School's insurance policies and determined that such policies appeared to be in force at June 30, 2011. We are not competent by training to comment on the adequacy of the insurance policies covering School owned property at June 30, 2011.*

Based on the results of our tests, the School has complied with the provisions of ORS 332.525 regarding the bonding of School personnel.

## **Indebtedness**

The School had no debt at June 30, 2011.

## **Programs Funded From Outside Sources**

We selected and tested, to the extent deemed appropriate, transactions, records, and reports relative to programs funded wholly or partially by other governmental agencies.

The results of our tests indicate, for the items tested, the School complied with the laws, rules, and regulations pertaining to programs funded wholly or partially by other governmental agencies, and for the items tested, financial reports and related data were in agreement with and supported by the accounting records.

Based on the results of our audit procedures, the School expended less than \$500,000 in Federal Awards. Therefore, the School was not subject to the requirements of OMB Circular A-133 Single Audit Requirements

## **Investments**

Based on our procedures, it appears that the School was in compliance with the legal requirements of ORS Chapter 294 pertaining to the investment of public funds.

## **Public Contracts and Purchasing**

Based on our procedures and our review of the minutes, the School appears to have complied with the legal requirements pertaining to the awarding of public contracts and the construction of public improvements as contained in ORS Chapter 279.

## **State School Fund Distribution Factors**

Based on our procedures, the School appears to have complied with the legal requirements as stated in ORS 327.013 and as further defined by the Oregon State Department of Education pertaining to the School's calculation and reporting of the factors used to compute the State School Fund distribution.
