During 2010-2011, 20 Liters invested in water testing equipment to determine which type of water filter would be the best in each area. They installed 150 sand water filters in Masaka, Rwanda, which each serve 20 people for a total of 3,000 people. They invested in bicycles to make home visits, maintain the water filters, follow up with the recipients and assess the health of the recipient families. They conducted random evaluations of 40 of these households to identify areas for program improvement.  
During 2010-2011, they also installed 3 rain water harvesting systems and repaired 1 harvesting system in Musheru and Masaka, Rwanda. These each serve 100 families of approximately five people for a total of 2,000 people. The tanks hold 10,000 Liters of water and have the potential of filling 60,000 20 L jerry cans per year. These systems were turned over to the local churches for supervision  
During 2010-2011, 20 Liters also began exploring a hollow fiber micro filtrations system, which could be another effective way to provide clean water. They also supported health and hygiene education in Rawanda.

During 2010-2011, 20 Liters created an exhibit for Grand Rapids Art Prize (which has over 200,000 visitors a year), created and maintained a website and spoke to students in 15 different schools to create awareness about the need to provide clean water solutions.
