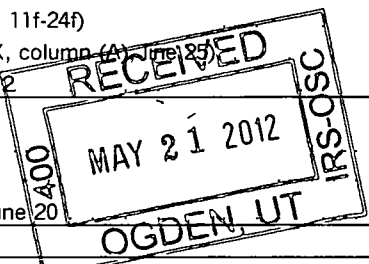

The Sacramento City Council has committed \$9 million to the project as part of its Community Reinvestment Capital Improvement Program bond issue and has extended a \$5 million bridge loan.
