



Domestic Violence Prevention and Treatment -

Establishes quality assurance standards for the operation of all domestic violence programs statewide, coordinate 17 peer reviews, and provides technical assistance and support to reviewed programs. Conducts annual statewide conference for over 200 professionals and advocates for a statewide crisis hotline where over 2100 calls were answered.

Federal Family Violence Prevention -

Supports comprehensive public awareness activities of the agency, training education, system and individual advocacy, membership services, batterers' intervention program certification, and programming for underserved populations.

Protective Order Pro Bono Project (POPBP) and Victims of Crime Act (VOCA) -

POPBP - The legal resource project provides legal representation and direct service advocacy to low income victims of domestic violence and stalking by seeking assistance in filing and enforcing orders of protections in Marion County Superior Court. The legal resource project provided direct legal assistance to approximately 125 low income individuals. The organization also provided information, referral, and supportive services to approximately 1,500 individuals seeking protective orders.

VOCA - Provided direct service to approximately 4,500 victims of family violence through legal assistance, advocacy, crisis counseling,

S.T.O.P. Training and Coalition -

Provides training and education to over 3,500 professionals statewide, distributed over 71,250 pieces of education materials, conducted approximately 150 trainings and responded to over 17,000 requests for technical assistance to member programs, public and private agencies, and victims. Provides for coordination and collaboration with all federal, state, and local entities to improve systems response and victim services.
