**SYNOPSIS:**

Raceland Upper Elementary School has a school population of 356 students, of which, 287 (81%) qualify for free/reduced lunches (2010-2011). Elementary students of today are engaged with technology through the use of video games, ipods, telephones, etc. They are free of fear of technology and quickly become engaged in the use of technology.

Effective teaching practices combined with interactive classroom technologies significantly boosts student academic performance. Dr. Robert Marzano, education researcher, states that individual student achievement is 16 percentile points higher when teachers effectively integrated interactive instructional tools into lessons.

This project seeks to implement an ActivClassroom into a 4<sup>th</sup> grade class.
