Every Child Succeeds' goal is to strengthen the parent-child relationship, encourage good health practices, promote self sufficiency and optimize children's development. Every Child Succeeds provides home visitation services designed to ensure an optimal start for children. Home visits take place from the time of pregnancy through the child's third birthday. Every Child Succeeds families receive two to four visits each month from home visitors. To date, Every Child Succeeds has provided more than 337,000 home visits and has served more than 16,600 families. At any one time, more than 2,000 families are receiving home visits. Program activities include: provision of the parents as teachers
