Grand Chapter. All of these events benefit the undergraduate/active
members. Alumni can attend all events, and in all cases are able to
volunteer as facilitators.

Risk Management: Provides liability insurance to the Fraternity's
undergraduate chapters located throughout the United States. Includes
68 chapters. Also provides risk management programs covering topics

Member Services: Provides support to the Chapter Development Team, who
advises the Fraternity's undergraduate chapters. The Member Services
area is in charge of all supplies, including inventoried items, items

spends most of their time managing this department (as seen in payroll
dollars).
