Under this program, the Organization provides cash grants to qualified tax exempt entities that provide health, mental health or juvenile intervention services to residents of Eastern Riverside County. These cash grants are funded annually by an agreement with the County of Riverside (CA) and the City of Palm Desert Redevelopment Agency.

4b (Code:) (Expenses \$ **193,798** including grants of \$) (Revenue \$)**Technical Assistance Program, TAP**

While cash grants are a major part of the Organization's activities grants of technical assistance became a priority when it was found that a variety of exempt organizations did not have the tools necessary to manage their organizations or grants. The Technical Assistance Program is funded by monies received annually under the agreement with the County of Riverside and the City of Palm Desert Redevelopment Agency. Other grants to the Organization come from other sources including the Desert Healthcare District, The California Endowment, etc.

4c (Code:) (Expenses \$ **185,503** including grants of \$) (Revenue \$)**Building Healthy Communities (BHC) Program**

The Organization's Building Healthy Communities Program is one of fourteen sites throughout the State of California that focuses on impacts to economically disadvantaged areas working to build a better quality of life for residents of the Coachella, Thermal, Mecca and North Shore areas of Riverside County. The California Endowment granted funds to the Organization for activities of the BHC Program.
