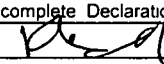

These facilities provide housing for individuals with social, emotional, intellectual and/or physical disabilities. Funding for the operation of these facilities is provided primarily by tenant rents.

The purpose of the Rental Subsidy Program is to assist individuals with severe and persistent mental illness to obtain permanent community housing. Funding for these programs is provided by the Lake County ADAMHS Board. The Rental Subsidy programs assisted 105 individuals during our fiscal year ended June 30, 2011.
