At any time, only six (6) Academic Trustees shall serve, each for three (3) year terms on a rotating basis, and up to six (6) Industry Trustees, Up to three (3) Independent Trustees, and Up to five (5) Ex officio Trustees, consisting of one person recommended by the Chancellor of the Ohio Board of Regents, one person recommended by the Director of the Ohio Department of Development, one person recommended by the NASA Glenn Research Center, and, one person recommended by the United States Air Force Research Laboratory. A quorum at any meeting of the Board of Trustees shall consist of at least two-thirds of the Trustees then eligible to vote. Business shall be determined by the affirmative vote of not less than a majority of the Trustees then in attendance and eligible to vote. In addition, an affirmative vote of at least three-fourths of the Trustees in attendance and eligible to vote shall be required to dissolve the Corporation, or to modify the number or classes of Trustees. The Trustees shall not receive salaries, fees or compensation for their service as Trustees or their attendance at any meeting or committee meeting of the Board of Trustees.
