The Institute has developed the following Centers of Excellence: Biomaterials and Medicine, Medical Device Development Center, Clinical Trials, and Community Outreach to the medically underserved. Their mission is to expand Akron's rich legacy in material science, and to pioneer the next generation of life-enhancing and life-saving biomedical innovations for the 21st Century.
