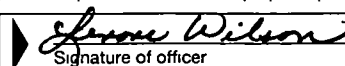

Okaloosa Walton Homeless Continuum of Care/ Opportunity, Inc. strives for the elimination of homelessness through prevention, alleviation, assistance in obtaining and maintaining self-sufficiency. Programs include emergency family shelter with case management, veterans employment programs, and support for the local Continuum of Care as lead agency and provider of the homeless management information system.

Okaloosa Walton Homeless Continuum of Care/ Opportunity, Inc. enrolled 35 homeless female veterans and veterans with families into the Homeless Veterans Reintegration Program during this time frame, and placed 20 of them into employment. Program services included educational remediation, occupational training, counseling, job readiness skills, assistance with transportation and child care, and the alleviation of other barriers to obtaining and maintaining a sustainable income.

4b (Code:) (Expenses \$ 148,007 including grants of \$ 117,649) (Revenue \$ 0)

Okaloosa Walton Homeless Continuum of Care/ Opportunity, Inc. provided homeless prevention/ rapid rehousing assistance for homeless households and households at risk for homelessness. Over the life of the program (10/1/2009-6/30/2011), Opportunity, Inc. provided case management, assistance with rent, utilities and moving costs to 470 households. Of these, 85% were able to obtain and maintain self-sufficiency during a six-month follow-up period.

4c (Code:) (Expenses \$ 58,990 including grants of \$ 55,990) (Revenue \$ 3,000)

Okaloosa Walton Homeless Continuum of Care/ Opportunity, Inc. distributed and monitored the use of funds to 14 agencies to assist in their program efforts to eliminate or alleviate homelessness. Agencies were awarded funds based on a competitive grant process, and used them to stock food pantries, provide severe weather shelter, underwrite costs of prescription medication and dental work, upgrade facilities for the use of the homeless, and provide prevention assistance to youth aging out of foster care. Over 7,000 persons were served through this grant.
