The student must designate the results be sent to Manchester College, and Indiana students must have a receipt date between Jan 1 and March 10 to be considered for state grant eligibility. 3. Submit any additional documentation requested by the College. Enrollment Requirements: Students receiving financial aid must maintain full-time enrollment, (a minimum of 12 semester hours) in each of the fall and spring semesters. There are circumstances in which part-time students demonstrating need may be awarded financial aid depending on the guidelines and availability of federal, state, and institutional funding. Part-time students must enroll in a minimum of six hours to maintain eligibility for institutional funds and loans. Degree Requirements: Students must be working toward their first baccalaureate degree to be eligible for federal, state, or institutional grants and scholarships. Students who have previously completed a baccalaureate degree are eligible for loans only.
