Dillard Harris Educational Center

Day Treatment: Through the Dillard Harris Education Center, We accept students with behavior disorders who have been unsuccessful in both regular and special education classrooms within their own public schools. The programs therapeutic approach focuses on meeting both the emotional and academic needs of students. Behavior modification, counselling and other supportive approaches are used to help students develop the necessary skills to return to their home school. For the year ended June 30, 2011, 8,410 child days of service were provided to 91 students.

Groundwork

A domestic violence program for battered women and their children. Program provides emergency shelter, counseling, and social services. The shelter is open 365 days per year, 24 hours per day. We also provide advocacy to victims of domestic violence, to assist those seeking orders of protection or wishing to press criminal charges. Prevention education is offered in schools, businesses and community organizations. During the year ended June 30, 2011, 10,360 days of shelter were provided to 349 people, 16,262 hours of counseling and advocacy services were provided to 1,237 clients and 1,414 hours of prevention education reached 6,188 people.
