We use Community Health Educators and other trained staff/volunteers to educate communities about how they can address lung health disparities and educate individuals about how to manage their lung disease. Currently, our programs include: Fight Asthma Now (for youth/teens), Asthma Management (for caregivers), Asthma-Friendly Child Care project, Addressing Asthma in Englewood, COPD State Plan, COPD Social Event, COPD Conference, Healthy Lungs Initiative, Lung Cancer Advisory Board, Radon Awareness efforts, etc.

Tobacco Control: Reduce smoking rates and reduce public exposure to
secondhand smoke.

Under a 2-year grant from the U.S. Department of Health and Human Services and the Centers for Disease Control and Prevention (through March, 2012), we are working with the Chicago Department of Public Health and more than 30 community organizations to reduce the burden of tobacco use in our community. Through the Chicago Tobacco Prevention Project, we are providing targeted resources to vulnerable populations in Chicago with higher than average smoking rates, and working to implement sustainable policies to screen for tobacco use and make regular referrals to local resources.

Research: Advance the understanding and treatment of lung diseases by supporting scientifically meritorious research.

Research on a wide range of lung disease issues is considered, including asthma, lung cancer, COPD, interstitial lung disease (including pulmonary fibrosis) and women's lung health.

Respiratory Health Association aims to fund the most promising research and strives to foster greater collaboration among researchers and among organizations that support lung disease research. Through the development of partnerships with other research organizations, Respiratory Health Association is able to maximize research awards and
