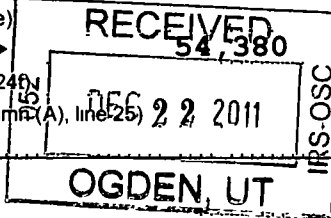

**Housing-** includes Housing Counseling & Home Sharing which provides clients with potential housing options, such as the homesharing program, Housing Choice voucher placements, senior housing applications, landlord and realtor negotiations, referral to low-cost apartments, referral to shelters and single room occupancy sites, facilitation of referrals to other agencies, and accessing financial assistance. 1,498 clients were served.

**Also, Transitional Housing** which provided shelter, case management, mental health and other supportive services to homeless families and individuals to help work toward self-sufficiency. 5,851 shelter nights were provided to 18 clients.

**Senior Support** - to help frail seniors and disabled individuals remain independent as long as possible by providing in-person assessments, ongoing case management, and geriatric counseling for senior clients and their families. 501 clients were served.

**The Organization** also provides licensed social workers for personal counseling and to facilitated support groups. 81 clients were served in 404 counseling sessions.

**Homelessness Prevention** - expenses associated with financial assistance to avoid eviction or foreclosure or to prevent utility disconnection. The program also includes case management and legal, financial and/or employment counseling. 133 households were served.

**Throughout all programs, the Organization's professional volunteers provide 1,188 hours of financial and legal counseling.**
