WITH THE ANNOUNCEMENT OF THE JAMESTOWN HOSPITAL MOVING FORWARD TO BUILD A NEW HOSPITAL, THE FOUNDATION HAS EMBARKED UPON YET ANOTHER CHALLENGING FUNDRAISING GOAL THEIR GOAL TO RAISE \$3,000,000.00 IS WELL UNDERWAY WITH DONATIONS AND PLEDGES OF OVER \$2,000,000.00. THUS FAR THE BUILDING PROJECT STARTED IN NOVEMBER 2009 AND IS SCHEDULED TO BE COMPLETED BY FALL OF 2011. THE FOUNDATION HOSTED ITS ANNUAL BREAKFAST WITH SANTA AND SILENT AUCTION, YOUNG AND OLD ALIKE ARE DRAWN TO THIS EVENT, WHICH KICKS OFF THE CHRISTMAS SEASON FOR THE JAMESTOWN AREA RESIDENTS. 160 PEOPLE PARTICIPATED IN THE FESTIVITIES AND \$6,859.50 WAS RAISED, THE FUNDS WILL HELP PURCHASE AN INFANT WARMER FOR FAMILY BIRTH PLACE FOUR TIMES A YEAR. WE SEND OUT "APPLESEEDS," A PUBLICATION USED TO KEEP OUR DONORS INFORMED ON WHAT WE ARE DOING AND TO ACKNOWLEDGE THEM FOR THE GIFTS THEY HAVE GIVEN. THE FOUNDATION ALSO HOSTS AN ANNUAL INVESTMENT IN EXCELLENCE DINNER TO HONOR DONORS WHO HAVE CONTRIBUTED \$1,000, \$5,000, \$10,000, \$25,000 OR MORE. 138 PEOPLE ATTENDED THIS YEAR'S EVENT. FORTY-EIGHT INDIVIDUALS, COUPLES AND BUSINESSES WERE HONORED BY THE FOUNDATION AS NEW MEMBERS ON THE WALL OF HONOR AND 26 MORE WERE RECOGNIZED FOR GIFTS THAT QUALIFIED THEM FOR THE NEXT LEVEL. THE FOUNDATION UTILIZES A PART OF JAMESTOWN HOSPITAL'S WEBSITE TO EDUCATE THE COMMUNITY ON THE SERVICES THE FOUNDATION SUPPORTS AND THE EVENTS THEY ARE SPONSORING. IT ALSO GIVES DONORS THE OPPORTUNITY TO DONATE ON-LINE. THE "HOUR" CLUB - PARTICIPATION BY EMPLOYEES IN SUPPORTING THE MISSION AND FUTURE OF JAMESTOWN HOSPITAL. IN THE PAST YEAR, 127 EMPLOYEE'S PARTICIPATED IN SUPPORTING THE HOSPITAL BY GIVING BACK WITH DONATIONS TOTALING \$2,500 EACH MONTH. THE FOUNDATION IS FORTUNATE TO HAVE MANY DIFFERENT LEVELS OF COMMUNITY SUPPORT. THE JAMESTOWN HARLEY DAVIDSON DEALER AND THE HOG (HARLEY OWNERS GROUP) HAS SPONSORED THE "BIG SPLASH" FOR SEVERAL YEARS NOW. THE EVENT IS HELD DURING THE WINTER AND LAST YEAR SIXTEEN VOLUNTEERS TOOK AN ICY PLUNGE TO HELP THE JAMESTOWN HOSPITAL HOSPICE PROGRAM. YOUNG AND OLD ALIKE JOINED TOGETHER TO RAISE \$11,083 FOR THE EVENT.
